A. All villages under section (A) were not registered with the Matabola Local Authority, which is the primary body that issues village numbers according to their scaling on the land map. This helps in making a village



independent and not to be an extension of other village that shares the same number. Our records however show that the villages above in section **(A)** shares the same number **(606LS)** which is the number that was registered for Moletjie location which was then randomly named Moletjie Moshate.

Remember one village one number, which will assist in terms of services like Clinics, Schools, Water and sanitation and many more services that a village should have. Currently all villages in section **(A)** are grouped as extensions of the main village, which in this case is Moletjie location. They will have to share the spoils as they are dependent on one village. The land registry office's map does not show those villages in section **(A)**. Because the local authority cares about its people; we are calling all village heads or community chairpersons or representatives to urgently contact the offices of Matabola Local Authority to arrange means and ways of [registering](#) their villages. This registration phase will help in villages being independent and qualifying for clinics, schools etc instead of sharing such facilities in high volumes.

B. New villages in section **(B)** do not appear anywhere on our records, they do not have village numbers except the same number in section **(A)**. These villages are mostly occupied by young generation with ambitions to be closer to primary services such as paved roads, shopping complexes etc. It is unfortunate that these villages were not legally constructed according to the Land Occupation Guidelines from Matabola Local Authority. The office of the king was contacted by numerous concerned residents, enquiring about services such as schools, clinics and electricity. Remember there is no government sector that can allocate funds to a non-existing village or in other words illegal settlements.

Lastly, if the residents accrued any charges over the land that they occupy, we are urging such residents of villages under section **(B)** to demand their monies back or open criminal cases (fraud) at their nearest police offices. Because the kingdom cares about its people; we are appealing to the village heads, community leaders or any person recognized to engage the offices of Matabola Local Authority on matters pertaining [registration](#) of villages. We are still looking into other areas of the province as we are not restricted to Capricorn only. Matabola Local Authority is for all parts of Limpopo province.
